Summary:	<p>Meeting was opened at 7:23PM by Mike Krager.</p> <p>Departmental budgets reviewed include MURSD, BOH, Council on Aging, Library and Highway.</p> <p>Overall budgets remained relatively flat as initially reviewed in prior meetings other than routine increases and contractual obligations. BOH reviewed current town trash removal and the upcoming 5 year contract renewal and the possible consideration of program expansion and standardization but will continue to investigate options with contract renewal with status quo. Library requesting additional staffing to support expanded operations, will investigate state grants/funding to offset initial costs.</p>
