

Chairman Goddard, Selectmen Reil and Schofield and Town Administrator Newman are in attendance at the Miscoe Hill School, Mendon. Chairman Goddard opened the meeting at 6:30 p.m.

Selectman Reil made and Selectman Schofield seconded a motion to approve the regular session meeting minutes of April 1 and April 21, 2015. The motion carried unanimously

There were no citizen statements, petitions or correspondence to the Board.

Selectman Reil made and Selectman Schofield made a motion to proclaim the weekend of May 16 and May 17, 2015 Mendon Lions Club Sight Weekend. The motion carried unanimously.

Selectmen considered their right of first refusal to purchase five lots on Thayer Road. Neither the Conservation Commission nor the Community Preservation Committee have an interest in having the Town purchase the property. A resident voiced concern that they are on a scenic road. *Action: Ms. Newman will speak with Mr. Ambrosino, Planning Board member, to bring the concern to his attention.*

The following topics were tabled until the May 4th meeting: discussion of the memorandum of understanding with the Blackstone Valley Chapter of the New England Mountain Bike Association for ongoing trails maintenance, using rectory for contractor's library construction office, selection of scholarship recipients, renewal of junk licenses and consideration of signing Mass. Preservation Project Fund Grant Application for study of Main Street Town buildings.

Selectman Reil made and Selectman Schofield made a motion to allow the Mendon Lions Club to hold a toll road at the corner of Route 16 and North Avenue from 8:30 a.m. to 12:00 noon pending the approval of Public Safety. The motion carried unanimously.

Selectman Reil made and Selectman Schofield made a motion to allow the Mendon Lion's Club to use lots #3 North Avenue & lots #6 & #20 Milford Street, on Saturday, June 27 and Sunday June 28, 2015 for Kelly Miller Circus parking pending an adequate Certificate of Insurance. The Town will waive all associated permit fees. The motion carried unanimously.

Chairman Goddard signed the MS4 General Permit Annual Report and the Commonwealth of Massachusetts, The Building Official Certification Committee New Employee Report Form for Timothy Aicardi and John Erickson

Chairman Goddard recessed the meeting at 6:38 p.m.

Selectmen and the Town Administrator attended Annual Town Meeting at 7:00 p.m.

Selectman Reil made and Chairman Goddard seconded a motion to adjourn the meeting at 9:00 p.m. The motion carried unanimously.
