Chairman Ammendolia, Selectman Goddard and Interim Town Coordinator Horn are in attendance.

Chairman Ammendolia opened the meeting at 7:43 p.m. and led the pledge.

Walter Swift approached the board asking if he needs to fill out his Hawker's Permit Application which is due January 31 since a new owner will be taking over Feb. 1. The business is open April through October. Selectman Tinio joined meeting at 8:47 p.m. Selectmen agreed Mr. Swift can renew the permit and the license can be transferred to the new owner.

Selectman Tinio made and Selectman Goddard seconded a motion to open the Massachusetts Electric Company (NGRID) hearing for Miscoe Road to feed a new house at Lot 1 Miscoe Hill Road, Upton, MA. The motion carried unanimously. Kevin Philbrick (owner) and Michael Roberts (National Grid) approached board. Selectman Tinio read the hearing notice. The Highway Surveyor has visited the site. Mr. Roberts explained electrical conduits and wires will be customer maintained in the public way. The public way will be discontinued at a later date. Highway Surveyor, Alan Tetreault joined the hearing. Alan indicated that an easement needs to be shown on the plan to access the conduit when the road is discontinued. Mr. Philbrick's engineer must show this on his plan. This plan should then go to National Grid. Mr. Philbrick plans to start work in the spring. Selectman Tinio made and Selectman Goddard seconded a motion to close the Massachusetts Electric Company (NGRID) hearing for Miscoe Road to feed a new house at Lot 1 Miscoe Hill Road, Upton, MA. The motion carried unanimously. Selectman Tinio made and Selectman Goddard seconded a motion to allow Massachusetts Electric Company (NGRID) to locate manholes, wires, and ducts, including the necessary sustaining and protecting fixtures, along and across the public way of Miscoe Road for NGRID to install 30' UG primary on private property and 1 25k single phase ug transformer on private property to feed new house at Lot 1 Miscoe Hill Road, Upton, MA. The motion carried unanimously. Mr. Philbrick will keep the town informed as to when construction begins.

Selectman Tinio made and Selectman Goddard seconded a motion to renew the Hawkers, Peddlers, Transient Vendors License of Walter Swift, 21 Anthony Road, Hopedale, to sell hot dogs, soda, coffee, doughnuts, Christmas trees and seasonal plants at 89 Hartford Avenue East Parking Lot pending positive routing slips. License shall expire December 31, 2013. Motion carried unanimously.

Selectman Tinio made and Selectman Goddard seconded a motion to approve the Executive Session Meeting Minutes of January 3, 17 and 30, February 27, March 12, 16, 26 and 28, April 2 and 23, May 1, December 10 and 22, 2012 and September 1, and 12, November 28 and December 5, 2011 and January 7, 2013 not to be released. Selectmen will
