Topic Name:	Blackstone Valley Regional Tech School Budget
Summary:	Dr Michael Fitzpatrick reviews his budget explaining he had hoped with the increase in student enrollment we would get an increase in state aid. This did not happen. The absolute minimum contribution is determined by the state in respect to the needs of each town, outside of the control of the school budget. This number for Mendon was \$51,000+ but he was able to reduce Mendon's total increase by \$11,000 making it \$40,567 increase from the previous year, or a total proposed budget for FY2016 of \$813,414.  Total increase in the overall BVS budget is only 1.6% but to be sure we should not worry about the quality of education being affected. The overall increase for the BV budget request for Mendon is 5.25%
