Topic Name:	Article 24 of ATM WARRANT Purchase of a Fire Pumper Truck
Summary:	Chairman Merolli explains that the Selectmen voted to make recommendation that we continue to stay on the 8 year lease on the Fire Pumper Truck at \$75,000 per year and then if the FEMA Grant comes thru we can reduce the amount of the lease. Chief Kessler explains that the 1993 front line engine must be replaced, and the 2003 Fire Truck has frame rot and needs to be replaced as soon as possible. So with the new pumper we can use the 2003 as a back up vehicle.
