Call to Order - Meeting opened 7:05pm

1. Hearing opened by Lynne Roberts for Demolition of addition at 8 Hartford Ave West

The owner would like to remove an addition on his house at 8 Hartford Ave West c. 1950 in order to rebuild it. This property is on the Historic Inventory List. The addition was constructed in the 1980's. Kathy moved to approve the demolition of the addition on the house at 8 Hartford Ave West. Dan seconded the motion. All members voted to approve the motion. Lynne closed the hearing. Kathy moved, Dan seconded all members voted to close the hearing.

1. Hearing Removal from Historic Inventory List as per the Demolition Delay Bylaw.

Lynne opened the hearing at 7:10 pm. Dan read the hearing notification to the people in attendance. Lynne explained the process and purpose for the hearing and the different designations of properties that are in a district or otherwise meet the first criteria of being 75 years or older. The list will be reviewed every year. Once a decision is rendered it stays in place. The list was requested to help determine which properties might need a closer look prior to demolition.
