Select Board Reorganization

Mr. Tinio made a motion to nominate Mark Reil as Chair. Second by Mr. Merolli.

Consider/Appoint-Anthony Davis, Economic Development Committee- Passed Over

Consider/Appoint- Mike Jones, Finance Committee Passed Over

Consider Common Victualler License- Herbs Make Scents, 4 Maple Street

Mr. Tinio made a motion to approve a Common Victualler License for Herbs Make Scents at 4 Maple Street, pending return of positive routing slips. Second by Mr. Merolli. The motion passed unanimously. Roll call vote: Reil-aye, Tinio-aye, Merolli-aye.

Discuss Proposed Marijuana Facility- JDM Sales ,103 Uxbridge Road

Attorney Ryan, representing JDM Sales, 103 Uxbridge Road, addressed the Board stating his client had a general question about Zoning Bylaws Section 6.03-B. Which limits the number of marijuana facilities to no more than three. Mr. Ryan asked if this was based on first come first serve basis. Ms. Newman stated yes and added that if there is an increase in applications the Board consider going back to Town Meeting to increase the number in the Town's Zoning Bylaws.
