### **Meeting** **Minutes**

At 6 PM a remote Select Board was called to order. Present: Lawney Tinio, Michael Merolli, Kim Newman absent: Mark Reil. Ms. Dupuis read the introduction to the remote meeting.

**Continue the Public Hearing for Showtime Entertainment, 49 Milford Street Application for the Alteration of Premises to Existing Alcohol License and Amendment to Existing Adult Entertainment License.**

#### **Public Hearing Notice**

The Mendon Select Board will hold a public hearing in the Upper Town Hall, 20 Main Street, Mendon, MA on the 28<sup>th</sup> Day of the month of September 2021 at 7:00 p.m., to consider the application for the alteration of premises for an existing annual general on-premises all alcoholic beverages license and amending an existing adult entertainment license for Showtime Entertainment LLC, George Funari, 49 Milford Street Mendon, MA 01756 under MGL Ch. 138, Section 12. This hearing was continued from 9/28/21 to 12/1/21. The public hearing will to be continued to another date. Public comment will be heard at that time.

Mr. Merolli made a motion to open the continuation of the Public Hearing for the application of the alteration of premises for an existing annual general on-premises all alcoholic beverages license and amending an existing adult entertainment license for Showtime Entertainment LLC, George Funari, 49 Milford Street Mendon, MA 01756. Step down second by Mr. Tinio. The motion passed

Mr. Merolli made a motion to continue the public hearing for Showtime Entertainment LLC 49 Milford Street, Mendon, MA 01756 to February 2, 2022 at 6:30 PM. Step down second by Mr. Tinio. The motions passed. The request to continue was submitted in writing by Attorney Michael Aleo.

#### **Consider Appointment of Provisional Career Firefighter/EMT- Leonard Morgante.**

Mr. Merolli made a motion to appoint Leonard Morgante to a provisional career Firefighter/EMT effective 12/6/21 at the contractual entry rate of \$23.86 per hour. This appointment is a provisional appointment to fill an anticipated Spring 2022 opening due to a pending retirement, when the retirement occurs the provisional aspect will be removed from this appointment. In the event the retirement does not occur, this provisional appointment will be rescinded and the provisional position vacated. Step down second by Mr. Tinio. The motion passed.

#### **Discuss FY23 Budget Calendar**

Mr. Merolli stated the budget calendar encourages the Finance Committee to come to the Select Board meetings. Mr. Merolli also would like to have the motions for Town Meeting given to the Finance Committee earlier than the day of Annual Town Meeting. Mr. Tinio suggested that even if there were a level service budget for a department he would like to have these departments join the budget meetings for any questions from the Finance Committee or the public. Mr. Merolli and Ms. Newman agreed. All departments will be required to attend budget meetings with the Select Board and Finance Committee.
