# Meeting Minutes

At 6:30 PM a regular Select Board meeting was called to order. Present: Mark Reil, Lawney Tinio, Michael Merolli, Kim Newman and Laura St.John-Dupuis. Mr. Reil led the Pledge of Allegiance.

# Consider Parade Permit- Brothers of the Brush Santa Parade for 12/3/21

Mr. Tinio made a motion to approve a Parade Permit for the brothers of the Brush Santa Parade on 12/3/21 at 6:30 PM from Miscoe to Clough down North Ave and authorize parking the town property on North Ave. Second by Mr. Merolli. The motion passed unanimously.

# **Consider/Interview Historical Commission Appointment- Constance Beal**

Mr. Tinio made a motion to appoint Constance Beal to the Historical Commission for a term to expire 6/30/24. Second by Mr. Merolli. The motion passed unanimously.

# Consider the Appointment of Career Firefighter/Paramedic- Shane Couming

Mr. Tinio made a motion to appoint Shane Couming to Career Firefighter/Paramedic at a rate of \$23.86 per hour with an additional \$1.50 pr hour paramedic stipend. Second by Mr. Merolli The motion passed unanimously.

# Consider Request to post a Provisional Career Firefighter/EMT- Basic position.

Mr. Tinio made a motion to authorize the Fire Chief to execute a hiring process for a Provisional career Firefighter/EMT position, with the provisional being the position will become a regular career appointment upon the expected retirement of a current career member. Should the anticipated retirement not occur and that employee returns back to work, this provisional position will be vacated. Second by Mr. Merolli. The motion passed unanimously.

#### Consider Authorizing the Fire Chief to enter into an agreement with a mutual aid town

Mr. Tinio made a motion to authorize the Fire Chief to enter into future agreements with a mutual aid town in order to facilitate the timely lending and/or borrowing equipment due to equipment breakdowns. Second by Mr. Merolli. The motion passed unanimously.

# **Consider Chapter 90 Project Request- Various Street**

Mr. Tinio made a motion to approve the Chapter 90 Project Request totaling \$50K for the following streets: Bicknell Drive, Colonial Drive, Crestview Drive, Lapham Court, Oak Hill Road & berm, Pudding Stone Lane, Puffer Drive, Russell Court and Warfield Road. Second by Mr. Merolli. The motion passed unanimously.

## Consider One Day Special License- All Alcoholic Beverages- Cedar Hill Farm Fair

Mr. Tinio made a motion to issue a One Day Special License for All Alcoholic Beverages to Michele and Mark Manoogian 43 Quissett Road for the Cedar Hill Farm Fair on 10/23/21 from 10 AM to 3 PM. with a rain date of 10/24/21. Pending the receipt of a certificate of liability insurance and the return of positive routing slips. Second by Mr. Merolli. The motion passed unanimously.

## **Discuss Block Party- Brothers of the Brush**

Brothers of the Brush member, Lawney Tinio stated that the brothers of the brush would like to have another block party. Mr. Tinio has discussed this with other people in Town who would be interested in volunteering. Ms. Newman stated that we will have to look back at the 350<sup>th</sup> Block Party and the funding.
