### **Minutes**

Mr. Reil stated that due to the meeting being hybrid Mr. Tinio is in person at the Town Hall, Mr. Reil is remote. All votes will be taken by roll call vote.

Mr. Tinio Read the Eagle Scout Citation

Mr. Tinio made a motion to award Eagle Scout Citations to Scouts, Aiden McCrae, Andrew Nagda. Step down second Mr. Reil. The motion passed.

Ms. Cook thought the appropriate name would be the Lorna Rhodes building as Lorna Rhodes was Mendon's first Librarian. Ms. Newman stated it is important to meet with the Board of Library Trustees to see if we are honoring the correct person and we want to check with the family for their approval of naming the building after Lorna Rhodes. Chairman Reil stated that it would be nice to formalize the name of that building again and suggests placing this topic on an upcoming agenda.
