Correspondence to the Board

a) Senior Citizens Day and Senior of the Year - Kevin Rudden

Mr. Tinio made a motion to proclaim Sunday, September 19, 2022 as Senior Citizen Day and to proclaim Kevin Rudden as Senior Citizen of the Year. Second by Mr. Chenelle. The motion passed unanimously.

Proclamation Awarded to The Senior Citizens of Mendon - Mr. Tinio Read the Proclamation

One of his proudest accomplishments is personally coaching more than 25 young men to the rank of Eagle Scout. Whereas: Kevin was previously a full-time and part-time reporter in Rhode Island and Massachusetts for 45 years. Kevin was honored by two Milford Civic groups for his work as a reporter for the Milford Town Crier newspaper. Whereas: Kevin is now in his third career, serving as the Principal Assessor in the Town of Holliston, chair of the Massachusetts Assessing Officers' Associations' Legislative Committee, and editor of the Northeast Regional Association of Assessing Officers' newsletter. Whereas Kevin is a member of the Mendham Brush Association (the Brothers of the Brush) and has served as co-chair as of the town's 350th anniversary celebration. Kevin "enjoys giving back to the community and [hopes] to continue doing so until [he] decides to retire. Consider Appointment - Mendon Police Officer, Toros Matellian

Mr. Chenelle made a motion appoint Toros Matellian to the position of Police Officer, Step 1 pay rate of \$1,092.30 per week. Second by Mr. Tinio The motion passed unanimously.

Consider Appointment- Conservation Agent- Maya Chuck

Mr. Tinio made a motion to appoint Maya Chuck to the position of Conservation Agent at \$30 per hour, upon conservation agent certification there will be a \$1.00 Increase. Pending a successful background check and has a one-year probationary period. Second by Mr. Chenelle. The motion passed unanimously.

Discuss/Consider Applewood Access

Ms. Anne Mazar, Land Use Committee Chair explained that the access to the open space is from an easement. What is needed is permanent access included in the deed. There is a space that is mostly wetlands. Town Counsel, Ms. Cindy Amara stated that she does not have any concerns or comments at this point.

Mr. made a motion to approve the subdivision of a portion of the town-owned 8 Morrison Drive for access to the Applewood Parcel C Open Space, as seen on the draft map and labelled, "Access Easement to Parcel C. Second by Mr. Chenelle The motion passed unanimously.
