At 7:00 PM, BOH Meeting has been called to order by Chairman Greenberg. As the Public Hearing at tonight's meeting wouldn't begin for another 15 minutes, Chairman Greenberg suggests they start off with the 3rd Agenda Item.

1st Item on Agenda **** DUMPSTER REGULATIONS PUBLIC HEARING ****

At 7:15 pm, Joyce makes a motion to open the Dumpster Regulations Public Hearing. Tom seconds the motion. The motion is passed.

Roll call vote: Greenberg-Aye, Fichtner-Aye, Gilmore-Aye.

Chairman Greenberg reads the Public Hearing Notice that was publicized aloud. After reading the Public Hearing Notice, Chairman Greenberg asks anyone in attendance for comments.

Ticia Low wanted to express her deep appreciation for the Board to bring this regulation to a vote and had a question about how the extension process would work. Chairman Greenberg said each extension would have to be applied for and would have to be reviewed and approved by the Board before an extension is issued. Ticia thanked the Board.

Chairman Greenberg asks for any additional comments from the public or from the Board Members. No one has any additional comments.

Chairman Greenberg calls for a motion to close the Public Hearing.

Tom makes the motion to close the Public Hearing. Joyce seconds the motion. The motion is passed.

Roll call vote: Greenberg-Aye, Fichtner-Aye, Gilmore-Aye.

Chairman Greenberg calls for a motion to adopt the Dumpster Regulations and make effective as of January 1, 2023.

Joyce makes the motion to adopt the Dumpster Regulations as written and effective as of January 1, 2023. Tom seconds the motion. The motion is passed.

Roll call vote: Greenberg-Aye, Fichtner-Aye, Gilmore-Aye.

Chairman Greenberg thanks everyone for their participation and moves on to the 2nd Agenda Item.

2nd Item on Agenda **Senior Discount Application Form and Process for Trash/Recycling Services**

Jack reviews the process of how the Senior Discount is applied to the Trash/Recycling Bills to the Town Residents that are 65 and older that they would have to fill out a form and send it back every year with the census.

Jack is recommending to the Board not have the resident complete the form, but instead, depend on the returned census from the resident, which would then automatically apply the senior discount to the bill if they qualify.

The Board is good with doing a trial run of this process, as long as the discount is applied to only those who have submitted a town census, in which the Town Clerk will verify.

Chairman Greenberg thanks Jack and since the 3rd Agenda Item was handled first at tonight's meeting, Chairman Greenberg moves on to the 4th Agenda Item.

3rd Item on Agenda 2023 Permit Applications Review and Approval

Jack has received renewal permit applications for the Boards review and approval. They include Tobacco Sales Permit Applications, Septic Installer Permit Applications, and Trash/Septic Hauler Permit Applications.

4th Item on Agenda Topics not reasonably anticipated within 48 hours prior to meeting

Chairman Greenberg would like to get back to Well Regulations and get that back up and running with Tom Ryder.

The Board sets its next meeting for December 14th at 7:00pm.

Chairman Greenberg calls for a motion to adjourn tonight's meeting.

Joyce makes the motion to adjourn tonight's BOH Meeting. Tom seconds the motion. The motion is passed. **Roll call vote: Greenberg-Aye, Fichtner-Aye, Gilmore-Aye.**

Meeting is ended at 8:20 PM.
