1 Myrtle Street-Local Upgrade Request

The applicant is requesting a Local Upgrade Approval for the proposed septic system repair for the above referenced property.

Title 5 requires that soil testing and percolation testing be conducted in the proposed Soil Absorption System area. A soil sieve analysis is allowed for repairs as a Local Upgrade Approval as long as at least one deep hole has been conducted in the area.

The sieve analysis confirms Loamy Sand conditions in the Soil Absorption area, the Engineer has designed the system according to the DEP's policy.

As this is a repair and the site limitations create constraints to upgrade to Title 5 new construction standards; I am recommending the approval of the Title 5 Local Upgrades a with a deed notice per the I/A Technology Approval letter that the site utilizes an Alternative system.
