Reviewed correspondence (postal, voicemail, and email)

 Received correspondence from Joe Urnato of Water and Wetland who will be doing a post management survey on Lake Nipmuc. Water and Wetland will go out onto the lake and review chemicals treatments that they did over the summer. Dan Byer is included, and the Lake Nipmuc association also met with them. In two weeks, the Conservation Commission will have a proposal to do some additional work with them.

1 Uxbridge Rd

1 Uxbridge Rd: DEP#218-0845 Notice of Intent submitted by Kendra Santamaria of Guerriere & Hanlon on behalf of applicant Dr. Patrick Assioun for the expansion of an existing parking lot, modification to the existing drainage system and infiltration basin, and associated grading at 1 Uxbridge Rd. Kendra displayed a special permit plan for 1 Uxbridge Road. They have approval from the Planning Board to purchase the building and put in a dental office. Discussed the site plan with Conservation Committee and questions were asked and answered.

Mike makes a Motion to accept the NOI, MassDEP – 218-0845. Expectation that the Order of Conditions would have no additional items that the Conservation Committee would want to have added in. So moved by Bob, seconds by Mike, All in favor – Passes Unanimously.

10 Old Taft Avenue

Discussion with Gregory Lambert regarding construction of a stone wall and work performed within the protected buffer zone of Lake Nipmuc, and take any action required. Karen Santamaria was there representing the homeowner; Mr. Lambert was also in attendance. The Conservation Committee wants to determine the best way to manage the paperwork and comply with DEP regulations. The homeowner would like to amend the open existing order to get work permitted. A partial certificate of compliance was given. The homeowner is asking to reopen the partially closed CoC and modify the NOI. It was discussed revising the existing NOI and resending letters to abutters.

ConComm's approval to go through when the paperwork is ready on October 12th. Kendra will come back with a new plan. Prepare public notice for October 12 meeting.
