The third request was for 29 Kinsley Ln for the cutting of five trees. A negative impact was determined, as long as the stumps aren't removed within 100 feet of the wetlands. All members were in agreement for the approval of the Jurisdictional Project Determination for 29 Kinsley Ln with these conditions.

The fourth request was for 188 Blackstone St for the construction of a 24x26 garage with a 12x20 breezeway attached to the north side of the house. A negative impact was determined. All members were in agreement for the approval of the Jurisdictional Project Determination for 188 Blackstone St.
