Call to Order - Meeting opened 7:05pm Open Public Hearing for 29 North Ave Detached Garage “Carriage House”

- o The Commission previously met with representatives from the Taft Public Library to discuss the detached garage building, which is called the carriage house, and its future.
- o Library members discussed the poor condition of the carriage house, which was being used for storage. They emptied it out and secured it due to safety concerns.

The Commission presented the historic background of the Carriage House and understood the safety issue it poses. They discussed the possibility of repurposing the building or salvaging materials before demolishing it. The building inspector suggested there was nothing suitable for salvage.

Dan made a motion that the Carriage House located at 29 North Ave. which does meet the standards for historical significance in its current condition is not preferably preserved and the permit for the demolition can be issued. Kathy seconded the motion all members voted in favor of the motion. Kathy will follow up with the abutter who was concerned with the demolition.

Kathy accepted a motion to close the hearing by Dan. Debra seconded the motion. All voted in favor.

Public Hearing 35 Cape Road

Notice is hereby given under the Town of Mendon General Bylaws Chapter XXXIII Sec. 4.2, Demolition Delay, of public hearing to consider the demolition of a detached garage structure located at 29 NORTH AVE, MENDON, MA. The hearing is scheduled for Jan. 25th, 2024, at 7pm to take place at the Art Homes Community Room at the Taft Public Library.

Dan Byer made a motion to open the hearing for 35 Cape Road. Kathy seconded the motion. All voted in favor. Mr. Tinio joined the table as representative and property owner. Mr. Tinio offered to have the group go through the building again prior to demolition. Kathy asked if there might be a chance to salvage a few chestnut beams to do repair work on the Olney Cook Shop. Mr. Tinio noted we could talk further about the possibility of working together on that.

Dan summarized the letter from an abutter who supports the demolition and would like to see the property used for commercial and designed to fit in the neighborhood. Mr. Tinio remarked that he is working with feedback from the abutting neighbors.

Dan made a motion to close the hearing. Kathy seconded the motion. All voted in favor. Dan made a motion

that although the structure is historically significant it is not preferably preserved in its current condition. The commission will not impose a delay and the permit is approved. Kathy Seconded the motion. All members voted in favor of the motion.
