Board reviews bond release letter from F & D Afonso concerning Pond Meadow Estates Subdivision.

A letter is to be sent to Mr. Afonso concerning the cleanup of the property existing from the barn fire and no lots will be release until the cleanup is done.

Board reviews the Citizen's Petition for proposed amendment to Section 3.01 Table A and Amend Article VI, section 6.02 "Solar Photovoltaic Facilities" (g)(i)(6). It was stated that it would be given to the Zoning By-Law Committee.

Mary Irons of 91A Providence St. appeared before the board to ask if the acceptance plan was received from Byron Andrews Engineering. Mary was told that we have not as yet

received the plan. She will get in touch with them. As soon as planning board receives plan we will let the BOS know so road acceptance can go on the warrant.
