## MINUTES OF MEETING JANUARY 28, 2019

Bill opens the meeting at 7:00PM.

Barry makes motion to approve the Minutes of Meeting for Nov. 19, 2018 as written; Damon seconds; all approved; John Vandersluis and James Quirk abstained.

Barry makes motion to approve the Minutes of Meeting for Dec. 10, 2018 as written; all approved; Damon Tinio and James Quirk abstained.

Barry makes motion to approve the Minutes of Meeting for Janu. 14, 2019 as written; John seconds, all approved; James Quirk and Damon Tinio abstains.

Mike Feldman appears for Miscoe Springs to ask for four bond reductions and one new bond.

Damon makes a motion to approve the reduction of the bond for Jewell Crossing, Sta. 0+00 to Sta. 8+00 – Section 1 from \$140,000 down to \$106,000. It is a reduction of \$34,000; John seconds, all approved.

Damon makes a motion to approve the reduction of the bond for Jewell Crossing, Sta. 8+00 to Sta. 12+56 – Section 2 from \$113,000 down to \$56,000. It is a reduction of \$56,000; John seconds, all approved.

Damon makes a motion to approve the reduction of the bond for Rawson Farm Drive (Road B) Sta. 0+00 to Sta. 5+83 – from \$135,000 down of \$70,000. It is a reduction of \$65,000; John seconds, all approved.

Damon makes a motion to approve the reduction of the bond for Rawson Farm Drive (Road B), town line; Sta. 5+83 to Sta. 10+15 – from \$102,000 down to \$64,000. It is a reduction of \$38,000; James seconds, all approved.

Damon makes a motion to accept a new bond for Locust Hill Drive; Sta. 0+00 to 11+50 – Section 5 for the amount of \$223,000; John seconds, all approved.

The total for the combined bonds are \$519,000.
