Mendon Annual Town Meeting – June 29, 2020 7:00pm Guidelines for Residents

- Location:** Miscoe Hill School, Football/Soccer Field (Behind School)
- Parking:** All attendees should park in the front parking lots and walk to the back of the school.
- Accessibility:** If someone needs assistance or handicap accessibility, they should drive around the north side of the school to the rear and someone will direct them to park on the baseball field. This is only for those who need assistance.
- Seating:** Residents should bring their own chairs for seating. A limited number of folding chairs will be available. Participants should space themselves socially distant (at least six feet apart). Families who live together can sit together.
- Weather:** The meeting will be held unless there is severe weather, heavy rain, or thunderstorms. If it is overcast, or even very light rain, we will try to hold it regardless. Participants should bring bug spray, an umbrella, a chair, and anything else they feel is necessary to be comfortable. If the weather is so bad, we will postpone the meeting to the next day, or if attendance is low possibly move inside the gym. That decision will be made the day of the meeting.
- COVID-19:** All residents over the age of 5 and staff must wear face coverings or masks in accordance with COVID-19 Order No. 31 and the Department of Public Health's Guidance while entering and exiting locations of town meeting or otherwise participating in in-person meetings, except where a person is unable to wear a face covering or mask because of a medical or disabling condition. A person who declines to wear a face covering or mask because of a medical or disabling condition shall not be required to produce documentation verifying the condition.
- Expectations:** We are counting on all attendees respecting their fellow residents, maintaining social distance at all times, and respecting the process so we can conduct the business of the town in a safe environment.
- Childcare:** There will be no childcare available. Due to the COVID-19 restrictions for childcare it is not possible to provide this for those who wish to attend.
- Process:** All residents who wish to speak must come to the speaker mic located in the front area, lining up at a six-foot distance. Individuals addressing town meeting may remove his or her face covering while doing so, provided that he or she is able to maintain a distance of at least six feet from other persons present. Speakers should limit their comments and questions to that which is necessary and nonrepetitive. Statements simply stating support or opposition are discouraged. All votes will be done per the Mendon Town Meeting Bylaws.
- Virtual Town Meeting** – We will hold a Virtual Town Meeting on Thursday June 25 at 6:00 PM to go through the ATM Warrant and answer any questions resident may have so that we can provide information ahead of the actual meeting.
