### QUITCLAIM DEED

I, Janyce-Ann Mathewson, as Executrix of the Estate of William H. Archibald, Worcester Probate Court Docket No. 98PR2136EP, of Mendon, Worcester County Commonwealth of Massachusetts

For consideration paid and in full consideration of LESS THAN ONE HUNDRED DOLLARS (\$100.00)

Grant to Janyce-Ann Mathewson, Individually, of 11 Providence Street, Mendon, Worcester County, Massachusetts

### WITH QUITCLAIM COVENANTS

A certain tract or parcel of land with the buildings thereon, situated on the westerly part of Mendon, Worcester County, Massachusetts, on the easterly side of the Old Turnpike Road, so-called, bounded and described as follows, to wit:-

Beginning at the corner of the wall on said road and easterly from the intersection of the Uxbridge Road and said Old Turnpike, thence on the wall N. 23° E. 18 rods to the end of the wall; thence N. 38° E. to a marked poplar tree at the southerly corner of the Dexter land, so-called; thence N. 40 ½° W. 20 rods; thence S. 38° W. to the end of the wall by the swamp; thence on said wall S. 25° W. 16 ½ rods to the first mentioned road; and thence southeasterly on said road to the place of beginning. Containing 7 ¼ acres more or less.

Also, one other tract of land on the southerly side of said Old Turnpike Road, so-called, bounded and described as follows, to wit:-

Beginning at a heap of stones on the west side of the Pound, thence southeasterly on said road to the northwesterly side of the Uxbridge Road; thence southwesterly on said Uxbridge Road to the end of the short wall and land formerly of Perry Wood; thence northerly on said land formerly of Perry Wood to the place of beginning. Containing 7 acres, more or less.




