June 1, 2022

Earl called the meeting to order at 10am. Members present: Earl Pearlman, Peg Nogueira, Diane Howell, Ann Vandersluis and Director, Amy Wilson-Kent. Also present: Dona Son, who will appear before the Select Board on June 22, 2022 for her appointment to fill one of the vacancies on the COA Board, and Friends' Vice President Betsy Edsall. We will reconsider this request in July when we have more facts. We felt it was too short notice with no time to advertize, possibly no available driver and it's the same day as the Progressive Yard Sale.

Betsey Edsall gave the Friends' report: there are now 78 dues paying members; many ads have been purchased for the Progressive Yard Sale map booklet; they did receive a scholarship application, which was awarded to Andrew Jacques, a Nipmuc senior. He has committed to 20 hours of volunteer service to the senior center; the Kennebunk ME trip is sold out; next meeting June 13, 2022.

Food Pantry Update—very well stocked; two Nipmuc students, who are concerned with food waste, want to donate non-perishable food items left over from their cafeteria to the food pantry; Mendon Drive-in contacted Amy to see if

we would like them to do a food drive for the food pantry; Amy is trying to get more details on this.

Senior Center Architectural/Engineering Study—nothing new—Anne Mazar said Dan Byer, who is on the Water Board, is awaiting more information.

Summer Functions—the menu is set for the Senior Cookout on Thursday July 14; last month we decided it was prudent to limit the indoor seating to 35 persons, so we will have outdoor seating under a tent or seating in the garage, if it is very hot; Amy will contact the Police and Fire Chiefs to see if they would like to help serve.

Senior Tea—Sunday July 31—Earl will entertain on the piano; the menu will consist of cucumber sandwiches, peach pie with whipped cream, coffee, punch and of course, tea.

Ice Cream Social—Wednesday August 24—Amy has a couple of possible entertainers in mind who will be sponsored by The Friends.
