The motion passed unanimously, with Peter Coffin (applicant) abstaining.

The Commission considered the Request for Determination of Applicability for a septic system installation at **6 Park St.** (also filed as DEP# 218-0777). Tim Aicardi made a motion, seconded by Mike Ammendolia, to find a negative determination as long as all areas marked on the plan for erosion controls include silt fencing in combination with either straw waddles or hay bales. The motion passed unanimously.
