### Meeting Minutes of April 11, 2019

Members present: Damon Tinio, Mike Ammendolia, Peter Coffin, Tim Aicardi, Bill Aten

Chairman Tinio called the meeting to order at 7:06 pm.

The Commission directed the Clerk to draw up a Notice of Intent to replace the expired Order (**DEP # 217-0725**) for Lake Nipmuc weed control, the Order to be considered at the next meeting.

Mike Ammendolia made a motion, seconded by Bill Aten, to sign the proposed contract with Solitude Lake Management for treatment of aquatic weeds in Lake Nipmuc during the summer of 2019. The motion passed unanimously.

7:15 pm: The Commission opened the Public Hearing for Notice of Intent for **39 Providence St. (DEP# 218-0784)**. Liz Mainini of Guerriere & Halnon (G&H), presented the proposal. G&H will prepare responses to DEP's comments and the Commission's request for culvert size specifications to present at the next meeting. Peter Coffin made a motion, seconded by Tim Aicardi, to continue the hearing to the next Conservation Commission meeting, currently scheduled for April 25, 2019 at 7:15 pm. The motion passed unanimously.

7:50 pm: The Commission opened the Public Hearing for Notice of Intent for **3 Locust Hill Dr. (DEP# 218-0783)**. Fred Lapham (of Shea Engineering) presented the plan. Tim Aicardi made a motion, seconded by Mike Ammendolia, to approve the plan as presented. The motion passed unanimously.

8:03 pm: The Commission opened the Public Hearing for Notice of Intent for **5 Locust Hill Dr. (DEP# not yet assigned)**. Fred Lapham (of Shea Engineering) presented the plan. Mike Ammendolia made a motion, seconded by Peter Coffin, to approve the plan as designed, pending DEP file assignment with no DEP comments. The motion passed unanimously.

8:07 pm: The Commission opened the Public Hearing for Notice of Intent for **39 Taft Ave. (DEP# 218-0782)**. Fred Lapham (of Shea Engineering) presented the plan. Peter Coffin made a motion, seconded by Mike Ammendolia to approve the plan as designed. The motion passed unanimously.

Mike Ammendolia made a motion, seconded by Bill Aten, to accept the Meeting Minutes of March 14, 2019. The motion passed unanimously.
