MINUTES OF MEETING MARCH 9, 2020

Bill opens meeting at 7:00PM.

Minutes of Meeting for December 9, 2019 on hold.

Bill explains the Master Plan with CMRPC.

Dale McKinnnon from Gueriere & Halnon distributes revised plans dated March 2, 2020 for 49 Milford Street.

7:15PM: Bill opens the Public Hearing for a Site Plan Review for 49 Milford St by reading the add published in the Milford Daily News.

Dale McKinnon to submit an NOI set of plans to Conservation Commission.

Proposed building will be 4,806 square feet with 75 parking spaces, 16 parking spaces behind the wetlands. There will be valet parking only 7 days a week. Entire lot is designated as entertainment. Occupancy will be 166 seats.

Jeff Walsh explains the plans that they received from Guerriere & Halnon.

There will be landscaping on the left side as well as a 6-foot stock-aide fence as well as trees and smaller shrubs.

Barry makes motion to approve the MOU for Applewood and to allow the Chairman, Bill Ambrosino to sign the MOU from Metacomet; John seconds, all approved.

Barry makes motion to close the meeting at 9:25, James seconds, all approved.
