7:15PM – Bill opens the continuation of the Public Hearing, Site Plan for 49 Milford St. An e-mail was sent by the applicant's attorney requesting continuation until Monday, August 24, 2020 at 7:15.

Barry makes motion to accept the email to continue the Public Hearing, Site Plan for 49 Milford St. to Monday, August 24, 2020 at 7:15; Damon seconds, all approved.

John Nenart submits a Site Plan/Special Permit application for a Public Hearing for 25 Cape Rd.

Damon makes the motion to set the Public Hearing for August 10, 2020 at 7:15PM; James seconds, all approved.

Gabrielle Belfit from Tighe and Bond makes a 30- minute presentation for the Stormwater Compliance.

John Nenart presents a Site Plan approval request for 5 Harrington St.. It is an amendment to a previous Site Plan approval. Because of change of use they need to do a Public Hearing.

Damon makes motion to set the Public Hearing for 5 Harrington St for Monday, August 10, 2020 at 7:30PM; John seconds, all approved.

Miraj Ahmed requested a Bond reduction for Cook's Crossing. Jeff Walsh from Graves Engineering submitted the report for the Construction Cost Estimate for Section 1 and Section 2.

Damon makes the motion to release bond amount for Cook's Crossing to leave a balance of \$100,000 for Section 1, Ammidon Road Station 0+00 to Station 8+00 and the Entire Length of Powder House Lane; John seconds, all approved.

Damon makes the motion to release bond amount for Cook's Crossing to leave a balance of \$92,000 for Section 2, Ammidon Road Station 8+00 to Station 12+57 (end) and Puffer Drive Station 0+00 (start) to Station 9+75; James seconds, all approved.

Letter needs to be sent to Miraj Ahmed stating the Bond Estimate was approved stating the above motions.

James makes motion to close the meeting at 8:30; Damon seconds, all approved.
