Committee determined all applicants qualified. Ken made a motion for a \$300 suggested donation for application #18-5; Joyce second; but all others voted against with goal of making one motion with a collective plan of how to handle awards for all 5 applications. Discussion was related to rationale to tie tax aid grants to average tax increase associated with the 2015 override (~\$500). After further discussion about alternative approaches, Ken made a second motion to grant \$500 per application for a total expenditure of \$2,500; Jenn second; all voted in favor of tax aid grants totaling \$2,500.
