| <b>ARTICLE 1</b><br>(BOS)     | To see if the Town will vote to transfer from available funds a sum of money to be used primarily for protecting public health through education and tire recycling or take any action in relation thereto.   |
| <b>ARTICLE 2</b><br>(FinCom)  | To see if the Town will vote to transfer a sum of money from available funds to Property and Casualty Insurance Expenses (Line 945B) or take any action in relation thereto.  |
| <b>ARTICLE 3</b><br>(FinCom)  | To see if the Town will vote to transfer a sum of money from available funds to Health Insurance Expenses (Line 914B) or take any action in relation thereto.   |
| <b>ARTICLE 4</b><br>(FinCom)  | To see if the Town will vote to transfer a sum of money from available funds to Town Hall Services Computer Expenses (Line 199E) or take any action in relation thereto.  |
