- **ARTICLE 18** To see if the Town will vote to raise & appropriate and/or transfer a sum of money from available funds for bridge and culvert repair; or take any action in relation thereto.
- **ARTICLE 19** To see if the Town will vote to accept MGL Chapter 59, Section 21A; or take any action in relation thereto. (Assessors)
- ARTICLE 20
  To see if the Town will accept a parcel of land on the northerly side of George Street in Mendon containing 24.16+/- acres and shown as Parcel A on a plan entitled "Open Space Community Plan 'Pond Meadow Estates' Open Space Parcel 'A' Key Sheet Plan of Land in Mendon, MA Scale 80 feet to an inch Date: January 22, 2014" by Guerriere & Halnon, Inc. and recorded with the Worcester Registry of Deeds in Plan Book 906, Page 86 (the Plan), as a donation from F&D Central Realty Corporation. Said Parcel A is being accepted for the following purposes: 1) to subdivide a portion of said Parcel A to create a separate lot that complies with applicable zoning for the area where the existing house and sheds at 34 George Street, as shown on the Plan, are located, for the purposes of selling said new lot, house and sheds in conformity with M.G.L. c. 30B and all applicable law; 2) to use the area presently or formerly occupied by a barn, silo, and adjacent shed, as shown on the Plan, together with an accessory parking area for community and other municipal purposes; and 3) to use the remaining land comprising said Parcel A as open space; or act or do anything in relation thereto.

## ARTICLE 21 (Historical Com)

To see if the Town will vote to transfer the care, custody management and control of the Union Chapel (Taft Public Library) and the land associated with that building located in the Mendon Town Hall Campus Area that are both located at 18 Main Street, Mendon, MA and have an Assessors Parcel Identification number of Parcel 18: 11-174-18 to the Board of Selectmen for the purpose of developing a plan for the preservation and adaptive municipal reuse and for the purpose of conveying a perpetual historic preservation restriction therein and other related uses, including the implementation of such plan, and to authorize the Board of Selectmen to convey a perpetual historic preservation restriction encumbering said Union Chapel land and building to the Commonwealth of Massachusetts, by and through the Massachusetts Historical Commission, on such terms and conditions, and for such consideration, as the Board of Selectmen deems appropriate; or to take any action relative thereto.

ARTICLE 22 (CPC)

To see if the Town will vote to transfer a sum of money from the CPA Historic Preservation Account for the purpose of repairing, restoring and resetting broken and damaged headstones and above-the-ground tombs in the Old Mendon Cemetery; or act or do anything in relation thereto.

ARTICLE 23 (CPC)

To see if the Town will vote to rescind the vote taken on Article 20 at the May 1, 2015 Annual Town Meeting and to replace it with the following: To see if the Town will transfer a sum of money from the CPA Budgeted Reserve Account and Open Space Account to fund a portion of the FY16 Fino Land Debt; or act or do anything in relation thereto.

ARTICLE 24 (CPC)

To see if the Town will act on the report of the Community Preservation Committee on the FY16 Community Preservation budget and to appropriate or reserve for later appropriation monies from the Community Preservation Fund annual revenues or available funds for administrative expenses of the Community Preservation Committee, the payment of debt service, the undertaking of Community Preservation projects and all other necessary and proper expenses for the year; or act or do anything in relation thereto.

ARTICLE 25 (CPC)

To see if the Town will vote to transfer a sum of money from the Community Preservation Historical Preservation Account to fund the repair of the roof and upstairs hallway ceiling of the Taft Public Library on 18 Main Street; or act or do anything in relation thereto.

ARTICLE 26 (CPC)

To see if the Town will vote to transfer a sum of money from the Community Preservation Budgeted Reserve Account to improve drainage and renovate the outfield on Tetreault Field at Veterans Park, 25 Millville Street; or act or do anything in relation thereto.
